## Notification and Consent:

1. Storage is wholly at the Owner's risk. This is the condition upon which the vessel and property is allowed upon the premises. We recommend that the yacht's insurance company be notified of this condition. **You are waving PYS liability by storing your boat and equipment at this facility.** The Owner agrees to maintain a suitable insurance policy on the vessel during repairs and in storage. Agreement to this stipulation by the Owner is evidenced by the presence of the vessel and its equipment. This condition is imposed in lieu of a surcharge on storage, representing the additional cost to PYS for catastrophic liability coverage.
2. Unless otherwise and specifically contracted, all work is performed on a time and materials basis at our published rates. If credit is extended, invoices are due and payable when presented. Accounts over 30 days will be assessed a 1.5% late fee charge each month until paid. The Marina & Boatyard Storage Act of 1993 allows PYS to dispose of boats and gear for which storage and service fees are owed for more than 90 days.
3. The Owner agrees that an express mechanics lien is acknowledged on the above vessel and equipment to secure the amount of repairs and storage thereto. The Owner further agrees to pay all collection costs and attorney's fees incurred to secure payment on overdue accounts.
4. No outside contractor may work on the premises without prior arrangements with PYS, all contractors must be fully insured and PYS reserves the right to bill a service charge for the use of the facility by any outside contractor. This charge is normally 20% of the invoice.
5. The terms of this agreement are fundamental and will stay in place from season to season although prices and conditions are subject to change without notice.
6. The Owner understand that boats in storage may be moved at the expense of PYS to accommodate the Portland Flower Show and Maine Boatbuilders Show.
7. Note: To best accommodate you during peak haul and launch season, please schedule 3 weeks prior to services requested.
8. This contract will automatically renew if the customer has made no other arrangements with the boatyard.
